Letter from the President

Looking Back to Look Forward

We envision a thriving Morgan County to be a healthy, beautiful place to live and work for current and future residents, where clean air and water, abundant wildlife, forestry, agriculture, and heritage tourism are vital and contribute to the regional economy.

We aim to preserve the beautiful public vistas, agrarian heritage, rural crossroads, and small town atmosphere while attracting small to medium sized businesses to provide essential jobs and sustain our balanced tax digest. We envision an organization that makes an impact locally and uses its success to promote

conservation and balanced growth throughout Georgia.

Membership Supper Recap



On a beautiful evening in March, 130+ Conservancy Members gathered at Dan Rather's historic barn at Malcom's Crossroads for the Annual Membership Supper. The chili was delicious, and we were treated to a presentation about Farmview Market from Farm Operations/Business Development Manager, Brad Kelly.

Why are we so thrilled Kelly Products, Inc. partnered with Morgan County BOC to develop Farmview Market? Well, we see that it serves as the retail leg of the three-legged regional food hub concept (aggregation/distribution, retail, processing) for which the Conservancy has been advocating since 2011 through our Regional Food Hub Committee. That committee consisted of local farmers, businessmen, Cooperative Extension, Chamber of Commerce, and city and county representatives and was the impetus behind the public-private partnership responsible for the development of Farmview Market.

We send a big THANK YOU to Kelly Products, Inc. and Morgan County BOC for their investment in Morgan County's agricultural industry. We now have an outlet for local farmers to sell their products, which should drive demand, which in turn should drive production and therefore farm income.

Educational Forum

Protect & Prosper: a Workshop for Land Use Professionals

On Thursday, February 25, 2016, 43 people gathered from all over the state to learn about innovative land use tools, many of which had been successfully used in Madison and Morgan County. The workshop was presented by the Madison-Morgan Conservancy in partnership with the Madison Historic Preservation Commission, the Madison Greenspace Commission, and the Madison Downtown Development Authority, and addressed how thoughtful planning for natural, historic, and cultural resources can spur sustainable development. Madison's Transferrable Development Rights (TDR) program was a key component of the workshop. The Conservancy intends to host this workshop annually to add to our robust educational programming.

Advocacy

A Trip to D.C.



For three days in April, the Madison-Morgan Conservancy was part of a select team of Georgia conservation leaders advocating for conservation initiatives to our Congressmen in Washington, D.C. Executive Director, Christine McCauley, was joined by Robert Ramsay, President of the Georgia Conservancy, and Alex Robertson, Legal Counsel for the Georgia-Alabama Land Trust, for the Land Trust Alliance's Advocacy Days (pictured above with GA Congressman Jody Hice).

Over 120 conservation leaders from all fifty states descended on Capitol Hill for three days to thank their congressional leaders for enacting one of the most powerful conservation measures in decades: the permanent enhanced federal tax incentive for conservation easement donations helping Americans conserve their land voluntarily. Conservation Easements

Love the Land, Love the Tax Incentive

Do you love your land? Do you want it (or part of it) to stay like it is forever? If the answer is yes, read on.

Over 2,550 acres in Morgan County are permanently protected by voluntary, donated conservation easements. Landowners here who have donated a conservation easement on part of their land have protected private land for public benefit and in return have claimed a federal income tax deduction.

This is not CUVA, the ten-year covenant that restricts development in return for a property tax reduction. A conservation easement is different: it's permanent (not a ten-year covenant), and it provides an income tax (not property tax) deduction.

Currently, the federal income tax incentive allows the donor of the conservation easement to deduct up to 50% of their AGI for a total of 16 years. And if you qualify as a farmer, you can deduct up to 100% of your AGI for 16 years. Not a bad deal.

The process is time consuming and complicated, and that's why we're here: to help you through it, to ensure it's the right tool for you and your family, and to ensure excellence in the transaction. Please contact us if you are interested in this conservation and estate planning tool, 706-818-8046.

The Politics of Density

One of the vital roles of local government is land use planning – Morgan County and the City of Madison are proceeding through their respective comprehensive planning processes which includes among other things a significant amount of land use planning. In the end, both plans will result in a map for the future, your future, and will affect your daily lives. The decisions made about land use during this process are critical: they will determine how long it takes you to get to the grocery store and if you'll see beautiful things like Malcom's Crossroads or Madison's historic district. Those land use decisions will be mapped in the Future Land Use Map (FLUM), and we think you need to know what it's going to look like.

The Conservancy's long-standing involvement in this community's comprehensive planning and our technical assistance to our local governments has made us acutely aware of the link between the decisions made during comprehensive planning and changes approved on the ground where we live. And to be blunt, you can't complain on the back end, if you're not involved on the front end.

Recently, the Conservancy's Development Review Committee (DRC) reviewed the Foster Park development proposal, to be located on the site of one of Madison's most important historic and greenspace resources. The DRC reported to the Madison Planning Commission, detailing the pros and cons of such a development. Yes, it's true, we believe density should be focused near infrastructure instead of sprawling through farmland, but we are concerned about the loss of this important Greenprinted resource.

We get to contribute on the back end, because we contributed significantly on the front end. The Conservancy helped the County and City of Madison draft a Greenprint in 2004. This map and document identifies 51 preservation opportunities. Then again in 2009, the Conservancy assisted in drafting the City of Madison's Greenprint Addendum, listing 30 preservation opportunities. Those Greenprints include a lot of public input and were adopted by the Board of Commissioners and Madison City Council in the Comp Plan as publicly approved lists of resources slated for preservation.

The Conservancy's Greenprint Ramble and other educational programming is designed to expose the public to the value of these resources so you are inclined to protect them if they are ever threatened.

Today one of them is threatened, and many of you are inclined to protect it, but we urge you to also get involved on the front end (now) during the comprehensive planning process so you have more input on what you see come out of the ground where you live. Ask your decision makers to include the Greenprint in the County Comprehensive Plan – it's the only method we have in Morgan County to identify important resources worthy of protection, and it's the backbone of any future preservation work in this community.



